

# **2017 BPAP Hall Of Fame Xtravaganza Rules**

## **1. Individual Eligibility**

- a. Participation is open to any bowler who is 21 years of age or older who bowls in a BPAP member center, and who is not currently bowling in a USBC Youth sanctioned league.
- b. Entrant cannot be a touring member of any national professional association.

## **2. Averages**

- a. Averages used for the qualifying period event shall be the **HIGHEST** of the following:
  1. Current league average of 21 or more games as of February 1, 2017
  2. Highest 2015-2016 Yearbook Average
- b. Bowlers without an average as required by this rule are ineligible to enter this tournament.
- c. Bowlers advancing to State Finals **MUST** provide printed average verification.

## **3. In League Qualifying**

- a. In-league qualifying shall consist of three (3) games of regular bowling during regularly scheduled league play. Pre or post bowled scores **CANNOT** be used for qualifying.
- b. Qualifying is based on pins over average for three games.
- c. For leagues that bowl more than three (3) games, qualifying is based on the **FIRST** three (3) games bowled.
- d. Multiple participation is allowed during the in-league qualifying.
- e. February 6 – 26, 2017 – Scores must be submitted by center by February 28.

## **4. Advancement from In League Qualifying**

- a. The highest qualifier during the qualifying period will be eligible to participate in the finals for the state event.
- b. If the highest in-league qualifier is unable to travel to the event in Las Vegas, then the second place team will be considered the advancing entry.

## **5. State Finals**

- a. State finals will be held March 6 - 12, 2017.
- b. Finals scores will be bowled through the bowlers league session of the same league used for qualifying.
- c. Scores from the finals must be submitted on or before March 14 at Noon (CST) to be considered for advancement to the national event.

## **6. Advancement from State Finals**

- a. The entry from all participating centers with the highest pins over average score will be awarded **ONE** entry (which includes two people) to the Hall of Fame Xtravaganza Tournament along with \$400 per person (2 people) to help offset travel expenses.
- b. If the advancing team is unable to commit to attend the Hall of Fame Xtravaganza tournament by March 20, 2017, they will be deemed ineligible and the second place team will be awarded the prize.
- c. The advancing entry will select the partner they attend the Hall of Fame Xtravaganza with.
- d. By advancing to the Hall of Fame Xtravaganza, both participants understand and agree to all rules and requirements associated with the event. Please ask your host center for information or visit:
